Rules

1. Junior category will have ALL teams members **15** years or younger while the senior team will have ALL team members over (**15**) years.
2. Solo Competition will only take place if a **MINIMUM** of 3 teams apply and **ONLY** 1st and 2nd Places will be given. If Less than 3 teams apply, Solo competition will be a featured performance.
3. No team entry will be accepted for the competition without a signed and completed application form.
4. Maximum performance time per team for competition is **7 MINUTES (including prop set-up time)**. Any team exceeding performance time of 7 minutes will be **DISQUALIFIED**.
5. Minimum size of a group will be **THREE (3)** members.
6. Participants will have to come **FULLY DRESSED** in their costumes for the competition ready to perform.
7. All choreographers will be provided the reporting time in advance, for the rehearsals on the day of the competition.
8. Rushhi Entertainment is the organizer of Dance Masti and its decision will be final and binding with **NO EXCEPTIONS**.
9. Once entries are received, choreographers will be sent the final schedule for the event with reporting times for each category.
10. The rules are subject to change at the discretion of Rushhi Entertainment Inc.
11. Any team not adhering to the above rules will be subject to disqualification.
